2009 Philipstown Conservation Advisory Council (CAC) Annual Report

In 2009, the CAC held 12 regularly scheduled public meetings. 22 applications were evaluated. 18 permits were granted by the Wetlands Inspector, and 7 reports were submitted to the Planning Board. CAC committee members visited all of the applicant sites to assist in the decision-making process, minimize environmental impacts and generate practical permit requirements.
