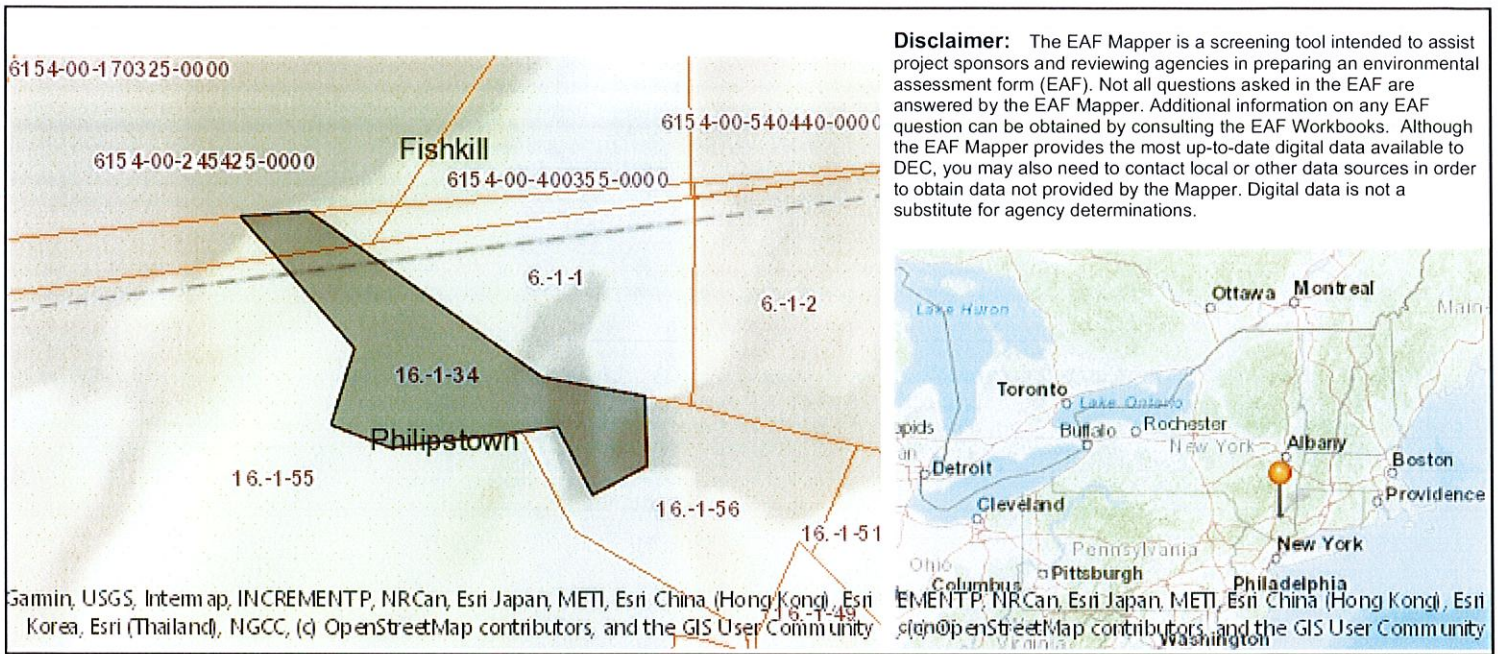

Brief Description of Proposed Action: New construction of a single-family residence (>3,000 sq. ft.) to be served by a subsurface sewage treatment system and a potable water well. Proposed gravel driveway (+/-1,400 ft.) shall generally follow the path of an abandoned road. Also, proposed is a detached accessory garage (24'x14') near the driveway entrance. The proposed driveway alignment requires construction in a town-regulated wetland buffer and an intermittent stream crossing in order to follow the abandoned road-bed, minimizing tree clearing and land grading.
