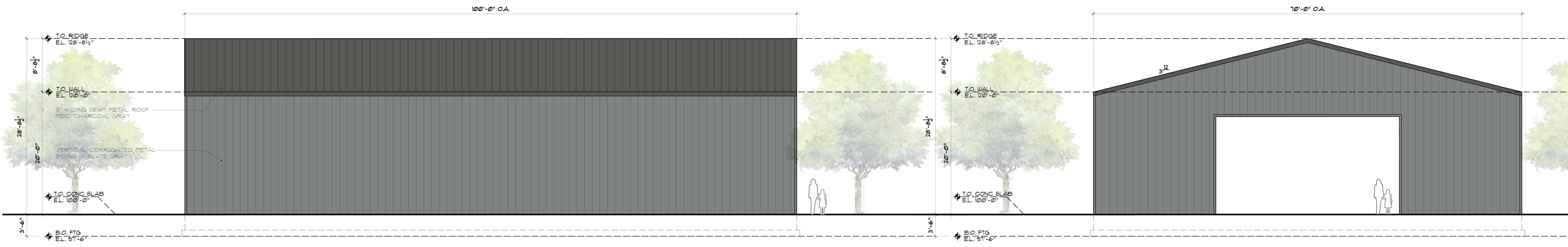

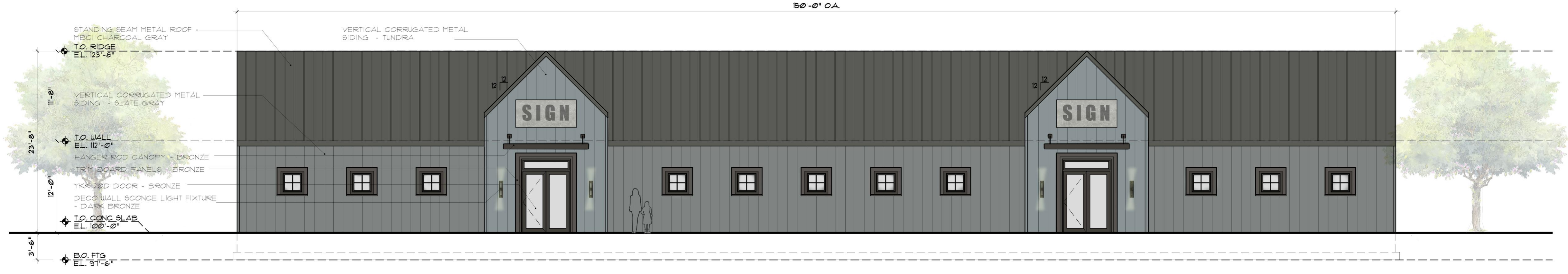

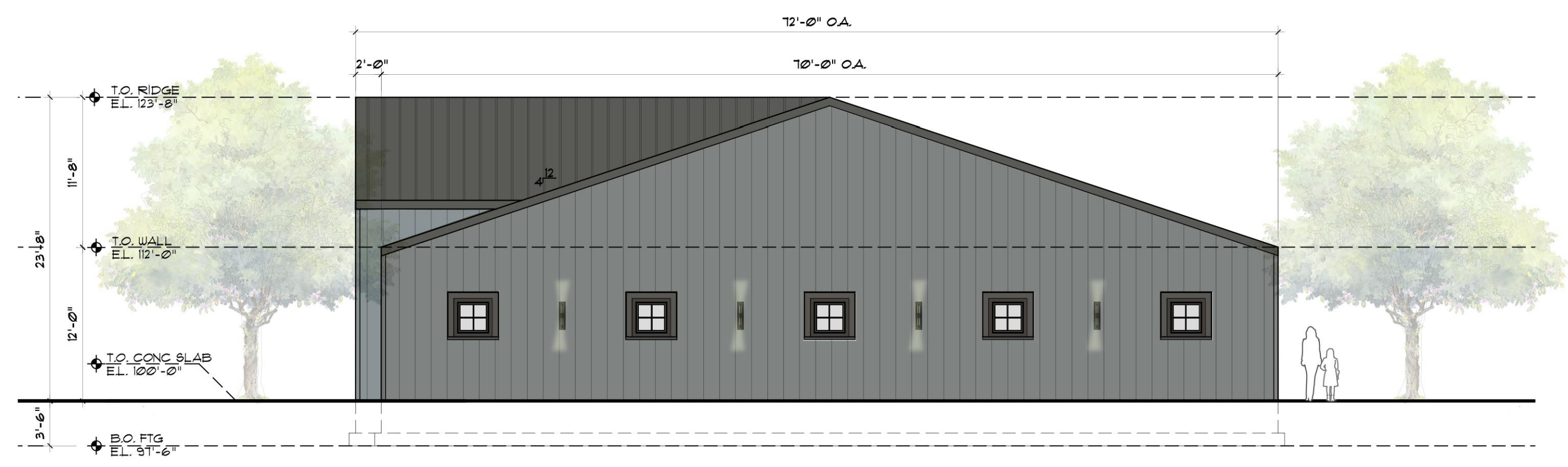


**1** Front Phase 1 Building  
A2.01 Scale: 1/8" = 1'-0"

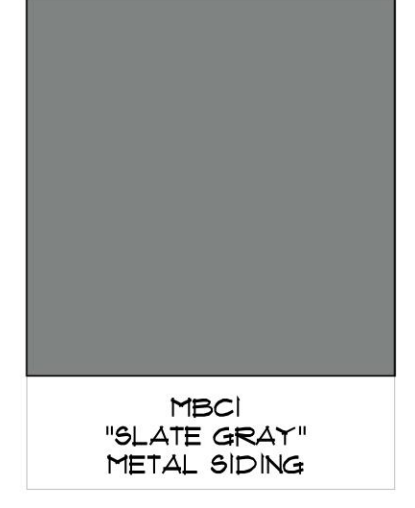
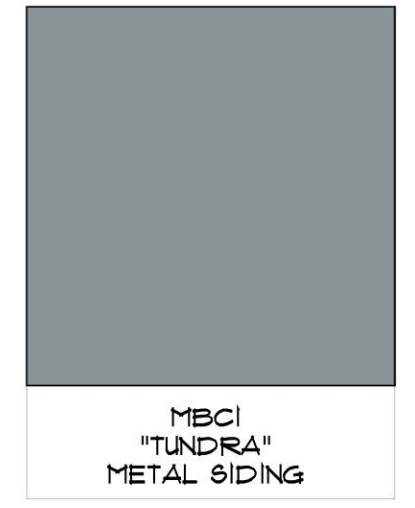
**2** Side Phase 1 Building

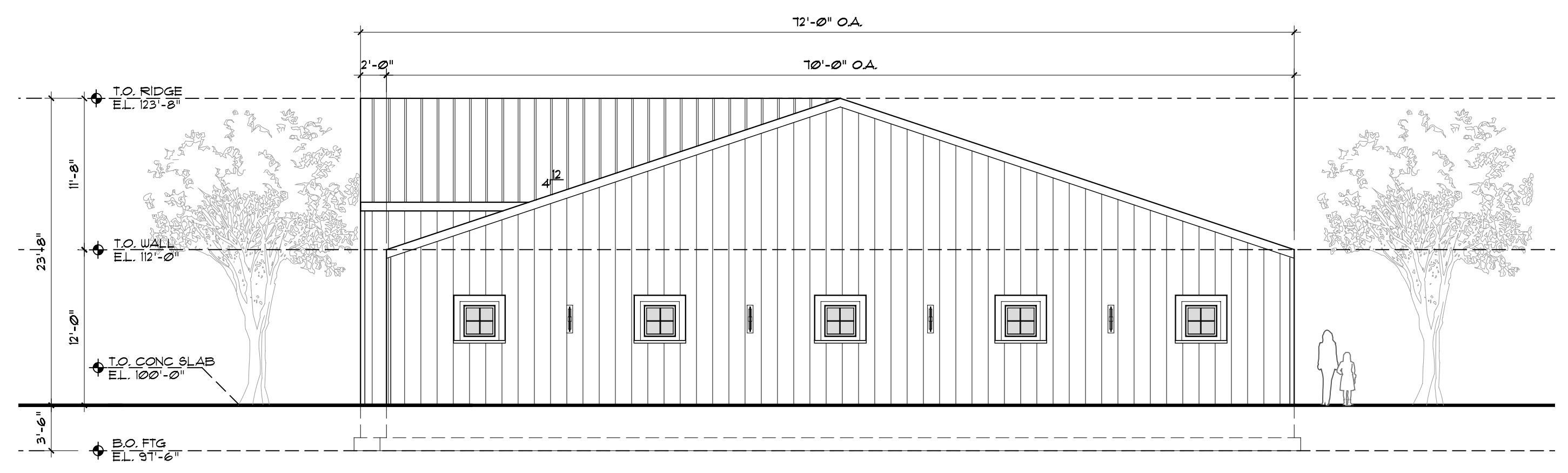


**1** Front Phase 1 Building
